CHIEF'S REPORT AND CURRENT EVENTS SUMMARY; by Fire Chief Joseph Speranza

- On behalf of the department, I would like to thank our members who participated in our annual Memorial Service and Parade.
- Tonight, we again have several new members joining us in the mission to keep our residents safe, we appreciate their service and applaud their commitment to be a Hawthorne Firefighter.
- With new members coming aboard we encounter the difficult challenge of outfitting our firefighters with safe and effective equipment, with this I wish to thank the Mayor, Administration Maurer and Council for quickly providing and approving a \$40,000.00 emergency resolution for firefighting turnout gear.
 - o In addition, several pagers have been ordered and expected within two weeks for our members.
 - Evaluating a few (2-3) of the older discontinued (5) pagers which could be retrofitted to work just for the short term.
- Training Center, the state inspection was completed last Wednesday and the inspector was thoroughly pleased with the progress and design of the center. I would like to congratulate AC Longo and our department as we have received certification to operate a FF1 class program as needed.
- Dept. Info, from the incident at 55 Westervelt on Memorial Day, a meeting was held last Wednesday with the owner, myself and Fire Official DeAugistines. I am pleased to report that

repairs are either in progress or already have been completed and we will be following up to insure repairs are completed. Mr. Gorga's phone number has been placed into the department phone book and Fire Desk system for future communications.

- The departments grant Drone has been ordered with the choice being the DJI Phantom 4 aircraft. Training will begin ASAP.
