Council President Matthews opened the meeting to the public. He stated if anyone desired to be heard, please raise your hand to be recognized, come forward to the microphone state your name and address for the record. He stipulated this be for agenda items only. Seeing none, Council President Matthews entertained a motion to close public comment, moved by Councilman Sinning, seconded by Councilman Bennett. Carried on voice vote.

#### ADOPTION OF ORDINANCES

### **BOND ORDINANCE 2215-18**

BOND ORDINANCE PROVIDING FOR INSTALLATION OF A NEW SURFACE AND RELATED IMPROVEMENTS TO THE MUNICIPAL TENNIS COURTS AT THE POOL COMPLEX, ALL IN AND BY THE BOROUGH OF HAWTHORNE, IN THE COUNTY OF PASSAIC, NEW JERSEY, APPROPRIATING ONE HUNDRED EIGHTY THOUSAND (\$180,000) DOLLARS THEREFOR AND AUTHORIZING THE ISSUANCE OF BONDS OR NOTES OF THE BOROUGH FOR FINANCING THE SAME.

The Municipal Council of the Borough of Hawthorne, in the County of Passaic, New Jersey (not less than two-thirds of all members thereof affirmatively concurring), do hereby ORDAIN as follows:

Section l. The improvement described in Section 3 of this Bond Ordinance is hereby authorized as a general improvement to be made or acquired by the Borough of Hawthorne, in the County of Passaic, New Jersey. For the said improvement or purpose stated in Section 3, there is hereby appropriated the sum of \$180,000, said sum being inclusive of all appropriations heretofore made therefor and including the sum of \$3,000 as the down payment for said improvement or purpose required by law and now available therefor in the Capital Improvement Fund of the Borough by virtue of provision in a budget or budgets of the Borough previously adopted. In addition, the sum of \$50,000 being provided through a grant from the Open Space Fund of the County of Passaic.

Section 2. For the financing of said improvement or purpose and to meet the part of said \$180,000 appropriation not provided for by application hereunder of said down payment and grant, negotiable bonds of the Borough are hereby authorized to be issued in the principal amount of \$127,000 pursuant to the Local Bond Law of New Jersey. In anticipation of the issuance of said bonds and to temporarily finance said improvement or purpose, negotiable notes of the Borough in a principal amount not exceeding \$127,000 are

hereby authorized to be issued pursuant to and within the limitations prescribed by said Law.

Section 3. (a) The improvement hereby authorized and the purpose for the financing of which said obligations are to be issued is the installation of a new surface and related improvements at the Municipal Tennis Courts located at the Municipal Pool Complex, together with all work and materials necessary therefor or incidental thereto, all as shown on and in accordance with plans therefor prepared by Boswell, McClave Engineering, P.E., now on file in the office of the Borough Clerk, and hereby approved.

(b) The estimated maximum amount of bonds or notes to be issued for said purpose is \$127,000.

(c) The estimated cost of said purpose is \$180,000, the excess thereof over the said estimated maximum amount of bonds or notes being the amount of the said \$3,000 down payment and \$50,000 Open Space Fund grant.

Section 4. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the chief financial officer; provided that no note shall mature later than one year from its date. The notes shall bear interest at such rate or rates and be in such form as may be determined by the chief financial officer. The chief financial officer shall determine all matters in connection with notes issued pursuant to this ordinance, and the chief financial officer's signature upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time subject to the provisions of N.J.S.A. 40A:2-8(a). The chief financial officer is hereby authorized to sell part or all of the notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The chief financial officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the notes pursuant to this ordinance is made. Such report must include the amount, the description, the interest rate, and the maturity schedule of the notes sold, the price obtained and the name of the purchaser.

Section 5. The following additional matters are hereby determined, declared, recited and stated:

(a) The said purpose described in Section 3 of this Bond Ordinance is not a current expense and is a property or improvement which the Borough may lawfully acquire or make as a general improvement.

(b) The period of usefulness of said purpose within the limitations of said Local Bond Law, and according to the reasonable life thereof computed from the date of the said bonds authorized by this Bond Ordinance is 15 years.

(c) The supplemental debt statement required by said Law has been duly made and filed in the office of the Borough Clerk and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Finance in the Department of Community Affairs of the State of New Jersey, and such statement shows that the gross debt of the Borough as defined in said Law is increased by the authorization of the bonds and notes provided for in this Bond Ordinance by \$127,000 and that the said obligations authorized by this Bond Ordinance will be within all debt limitations prescribed by said Law.

(d) An aggregate amount not exceeding \$35,000 for items of expense mentioned in and permitted under Section 40A:2-20 of said Law may be included in the foregoing estimate of the cost of said improvement or purpose.

Section 6. The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and interest on the said obligations authorized by this Bond Ordinance. Said obligations shall be direct, unlimited obligations of the Borough, and the Borough shall be obligated to levy ad valorem taxes upon all the taxable property within the Borough for the payment of said obligations and interest thereon without limitations of rate or amount.

Section 7. The capital budget of the Borough is hereby amended to conform with the provisions of this Ordinance to the extent of any inconsistency herewith. Resolutions in the form promulgated by the Local Finance Board showing all detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, are on file with the Borough Clerk and are available for public inspection.

Section 8. This Bond Ordinance shall take effect 20 days after the first publication thereof after final adoption as provided for in said local bond law.

The Ordinance published herewith was introduced and passed upon first reading at a meeting of the Municipal Council of the Borough of Hawthorne, in the County of Passaic, New Jersey, held on September 5, 2018. It will be further considered for final passage after public hearing thereon, at a meeting of said Municipal Council to be held in the Municipal Building, 445 Lafayette Avenue, in said Borough on October 3, 2018, at 7:00 p.m., at which time and place all interested members of the public who desire will be given an opportunity to be heard in connection with said Ordinance, and during the week prior to and up to and including the date of such meeting, copies of said Ordinance will be made available at the Borough of Hawthorne website, <a href="https://www.hawthornenj.org">www.hawthornenj.org</a> and at the Clerk's Office in said Municipal Building during regular business hours at no cost to the members of the general public who shall request the same.

# **Public Hearing**

Council President Matthews opened the meeting to the public. He stated if anyone desires to be heard regarding this ordinance please raise your hand to be recognized, come forward to the microphone and state your name and address for the record.

Seeing none, Council President Matthews entertained a motion the public hearing be closed and be it resolved that this ordinance was posted on the bulletin board on which public notices are customarily posted, published in the Hawthorne Press and available on the borough website. Copies of said ordinance were made available to the general public. Now, therefore, be it resolved this ordinance be adopted and the Clerk is authorized to advertise the same according to law, moved by Councilman Lane, seconded by Councilman Bennett. Councilman Mele stated we received a \$50,000 Open Space Grant for this ordinance, and an additional \$50,000 from the Columbia Bank Foundation. On roll call, all voted yes, motion carried.

### **OLD BUSINESS**

Councilman Wojtecki reported 19 Elberon Avenue still has an upside down No Parking sign, it was noted that it would be fixed the next day.

Councilman Bennett asked the status with the baseball fields in the park on the corner of Diamond Bridge and Goffle Road. Mayor Goldberg stated they were told they were going to lose a full season. Councilman Wojtecki also commented, "It is my understanding that there are changes to the plan which include irrigation and drainage".

Councilman Lane asked Engineer Boswell to give the Council a completion schedule for the DPW garage. Engineer Boswell stated the Council approved a change order at no extra cost with a completion date of November 1<sup>st</sup>. The garage door installation will start tomorrow, the lighting will be installed next week and we are still resolving the need for ventilation. Councilman Lane asked if the existing structure with the alarms and sprinklers would be finished by November 1<sup>st</sup>; Engineer Boswell stated the entire building will be completed. He then asked if there is an area where they will be able to make brine; it was stated by DPW Director Scully they will make it work.

Council President Matthews asked Administrator Maurer if there could be a small dumpster at the recycling center for bottle caps due to the recent changes to the recycling rules. Administrator Maurer stated we are looking to find markets to take the items to.

### **NEW BUSINESS**

Councilman Lane asked Administrator Maurer to send property maintenance to Goffle Road and Ivan Place where a resident has taken down a concrete wall and has the sidewalks blocked off, for about a month now. Administrator Maurer stated he would have someone take a look.

Councilman Wojtecki asked who is responsible for the clean-up of the pocket park on Lafayette & Diamond Bridge Avenue and stated Rick Hockenberry would like to volunteer to do some trimming there. Attorney Pasquale stated it is the Borough's responsibility and is done through volunteers. Councilman Wojtecki asked for approval for Rick to handle; all agreed it was a kind and generous offer and thank you.

# **ADMINISTRATIVE AGENDA PRESENTED BY MAYOR GOLDBERG**

Mayor Goldberg remembered former Mayor Fred Criscitelli who passed away Monday evening and served as the Mayor of Hawthorne for two terms. Hawthorne Day was a great success, the new setup this year worked well. He thanked all of the sponsors and his Hawthorne Day Committee for making the day possible. Many thanks to Joe Ross, the Police Department, DPW, Ambulance Corps., Fire Department, Board of Education and the Hawthorne Boys & Girls Club. Next year's date is Saturday September 22<sup>nd</sup>, forms will be available on our website after January 1<sup>st</sup>. I was honored to attend the DVRT vigil that was held last Wednesday night at Borough Hall, October is Domestic Violence Awareness Month and Breast Cancer Awareness Month. The 4<sup>th</sup> Annual Taste of Hawthorne took place at Macaluso's, he thanked the Rotary Club for a wonderful event. The Chamber of Commerce' Restaurant Week starts this Saturday October 6<sup>th</sup>. October 7<sup>th</sup> through the 13<sup>th</sup> is Mental Illness Awareness Week by the National Alliance on Mental Illness. This year's theme is Cure Stigma, more information can be found on their website CureStigma.org. This Saturday October 6<sup>th</sup>, the Passaic County Board of Chosen Freeholders together with the Passaic County Sheriff's Office Friends of Passaic County Parks will host the 3<sup>rd</sup> Annual Paws in the Park from 10am to 3pm in Goffle Brook Park. The rain date is October 7<sup>th</sup>. For more details go to their Facebook page Passaic Paws in the Park. The Mayor's Halloween parade is scheduled for Tuesday, October 30<sup>th</sup> at 7pm at the Roosevelt School gym.

### **Borough Attorney Michael J. Pasquale**

Attorney Pasquale offered his condolences to the Criscitelli family and shared thoughts on the passing of the former Mayor.

<u>Affordable Housing</u> – Mr. Pasquale reported that additional conference calls and email exchanges have taken place regarding both the 204 Wagaraw Road property and the Borough as a whole. A further conference has been set for November 8th.

<u>Revaluation</u> – Mr. Pasquale reported that two proposals were received by the Borough Clerk last week for performing the revaluation scheduled to take place in 2019. The proposals will be reviewed by Tim Henderson

and together with the Administration a recommendation for award of contract will be presented, most likely at the next meeting. In the coming months details for the residents about what is entailed in a revaluation will be provided.

# Borough Engineer Dr. Stephen T. Boswell

<u>Arlington Avenue</u> – Final payment documents were prepared and submitted to the Borough, a deduct change order for \$585.95 was submitted for as-built quantities Borough funded, and a deduct change order for \$6,747.44 for as-build quantities resident assessments, were submitted.

<u>Band Shell Restrooms</u> – B. Puntasecca addressed the door frame issue. Quotes from both Montone and Ruta were requested for the revised ADA viewing pad and pathway design.

<u>Goffle Hill Water Storage Tank Drainage Improvements</u> – John Garcia Construction is a few weeks out and probably will not start the drainage improvements until November. A pre-construction meeting was held on Thursday, September 20<sup>th</sup>.

<u>Water Storage Tank LSRP Services</u> – A complete horizontal and vertical delineation of the area surrounding the tank was performed. A cost estimate to remediate the area is being prepared.

<u>2017 Road Program</u> – Deduct change orders for as-built quantities were included for the following funding sources; \$92,053.46, Borough funded, \$5,991.80, resident assessments and \$25,539.08, CDBG

<u>DPW Building</u> – Council President Matthews asked Engineer Boswell why we needed to reconfigure the oil water separator. When the oil water separator was being installed, the invert of the sewer pipe was not the same as indicated on the plan, so it had to be cut down in order to meet the grade.

<u>Municipal Pool</u> – Final payment documents were prepared and submitted to the Borough. A leak was observed at one of the elbow pipes that will be addressed when the pool is operating.

<u>2018 Road Program</u> – A revised punch list was provided to America Asphalt on October 2<sup>nd</sup>, a site meeting is scheduled for next week.

<u>Lafayette Avenue Streetscape</u> – A recommendation letter to award the base bid in the amount of \$339,280 to Zuccaro Inc. was submitted to the Borough.

<u>Roof Repairs for Sewer and Water Dept. Structures</u> – Roof repairs have all been completed on all six structures. Payment documents will be submitted before the next meeting.

<u>Mary Street Water Storage Tank Painting</u> – The pre-construction meeting was held on the 20<sup>th</sup>. The Water Department has begun draining the tank. The rehabilitation was expected to begin in November however, Brave Industrial would like to begin in October.

<u>Municipal Pool Improvements</u> – Various improvements associated with the municipal pool were discussed with the administrator and will be a project for next year.

<u>Royal Avenue Drainage Improvements</u> – The estimate has been given to the grant writer.

<u>2019 NJDOT Municipal Aid Application – Arlington Avenue, Phase 2 and Alexandria Avenue</u> – The 2019 NJDOT Municipal Aid Application for Arlington Avenue, Phase 2, and Alexandria Avenue is prepared and will be submitted electronically, via SAGE, the week of October 1<sup>st</sup>. The borough has already provided our office with the appropriate resolution for the application.

<u>Library Roof Leaks</u> – The section of roof associated with the leaks in the loft area has not been replaced for over 20 years. Replacement costs were originally requested from both Paino and Pfister Roofing. The Library director, Mary Ellen, has been informed of the situation.

<u>Wagaraw Road Tennis Courts</u> – Our proposal for design and inspection for the new tile surface for the Wagaraw Road tennis courts was submitted to the Borough, once authorized, bid documents can be prepared in two weeks.

Mayor Goldberg stated he has started a Mayor's advisory committee for the pool to make recommendations on improving the pool. Our first meeting was on Monday, we will be having another one in a couple of weeks.

# **Borough Administrator Eric Maurer**

Our application to the New Jersey EEA for Hazardous Discharge Site Remediation Fund Grant for Pyrolac has been submitted by our consultant EWMA. Last week we sold \$5,083,000 in bond anticipation notes to cover our 2017 and 2018 Capital Programs. We received a net interest cost of 2.248% which is a higher rate than

previous years, this reflects increasing market interest rates. We received a notice from the City of Newark seeking a reduction in its apportionment from the Passaic Valley Sewerage Commissioners. A hearing is being held next Tuesday which I will be attending in order to oppose this proposal.

Clerk DiBella reported the online auction was held last month on govdeals.com, there were two dump trucks, two pickup trucks and a Crown Victoria that netted about \$14,000 from the DPW department. There are some miscellaneous DPW items going up for auction in the next couple of weeks. We have netted \$80,000 over the years using govdeals.com.

# **QUESTIONS FOR THE ADMINISTRATION**

Councilman Wojtecki asked the status on "dead tree" replacements. Administrator Maurer stated he would look into it. Councilman Wojtecki reported that at the Shade Tree Commission meeting they had discussed a tree near the intersection of Goffle Hill Road and Union that is leaning over the retaining wall and appears to be a hazard. He asked if the ordinance committee would consider an ordinance in regards to removing a tree that is in a hazardous state. He also asked the administrations plan for grass clippings and yard waste pick-up due to the extended warm weather. Mayor Goldberg stated in the past we have asked residents to cut it and leave it, but stated they would look into it.

Council President Matthews entertained a motion to record the Administrative Agenda, moved by Councilman Sinning, seconded by Councilman Lane. Carried on voice vote.

Councilman Mele reported the Municipal Alliance met last week, next year's grant is being worked on by Lori and Joanne, committee members. The Peer Leader Club from the High School is working on a new project.

Councilman Lane asked if the Arborist could take a look at a tree at the dead end of Pasadena Place.

Council President Matthews reported the Planning Board met last night and a gas station application for the old Shell Station was presented to us. The Board deferred it to the Zoning Board due to possible abandonment. The annual Chamber of Commerce Fishing Derby was held last Saturday, over 140 fish were caught. The 7<sup>th</sup> Annual Restaurant Week starts this Saturday, October 6<sup>th</sup> through October 13<sup>th</sup>. There will be craft shows at the Farmers Market on October 7<sup>th</sup> and 14<sup>th</sup>.
