LANDSCAPERS for Leaf Season ONLY -- The use of the compost site is a privilege, not a right. The DEP has made the rules governing the use and maintenance of a compost site far stricter than it has been in the past. **Downes Tree Service**, the current operator of our site, has the right to revoke the permit of any landscaper that does not adhere to these rules. **To use the site, you must agree to the following rules:**

- Only leaves from the **Borough of Hawthorne** can be brought to the site. If the contractor feels you are abusing your permit, he can revoke it.
- **There can be no debris in your material.** Coffee cups, metal, and paper are all considered debris.
You must bring in clean loads.
- **You cannot dump your material if there is no staff on site.**
- **Absolutely NO grass.** The Borough can lose the use of the facility if grass is brought on site.
- You can only dump in the designated area. It will be clearly marked.
- You may dump from 7 a.m. until 3 p.m.
- You must provide an up-to-date accurate customer list, with address and phone numbers.
Spot checks will be done.

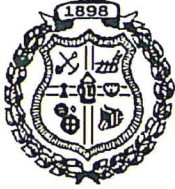

Dear Landscaper:

As part of your Landscaper Permit application, you opted to have your company included in the Borough's "Court / Code Ordered Maintenance" program for 2020. In order to participate in the "Court / Code Ordered Maintenance", you must submit a Certificate of Liability Insurance, specifically naming "the Borough of Hawthorne as an additional insured with respect to work done on behalf of the Borough", and providing general liability coverage, and evidence of worker's compensation coverage, including, bodily injury and property damage with minimum limits not less than \$1,000,000. The Code Ordered Maintenance must be completed within 24 hrs. of acknowledgement.

Please provide the same to the Borough as soon as possible. If a Certificate of Insurance is **NOT** received, you will not be called to participate in any "Court / Code Ordered Maintenance".
