ORDINANCE NO. 2146-15

AN ORDINANCE TO FURTHER AMEND AND SUPPLEMENT CHAPTER 505, VEHICLES AND TRAFFIC, ARTICLE VII, EMERGENCY NO PARKING, SECTION 505-43, DESIGNATION OF SNOW EMERGENCY NO PARKING AREAS, AND SECTIONS 505-44 AND 505-45, RELATED THERETO, AS WELL AS SCHEDULE XXI, SECTION 505-75, SNOW EMERGENCY NO PARKING AREAS, SO AS TO IDENTIFY LOCATIONS THEREUNDER, OF THE CODE OF THE BOROUGH OF HAWTHORNE

BE IT ORDAINED by the Municipal Council of the Borough of Hawthorne, in the County of Passaic and State of New Jersey, that:

Section 1. Chapter 505, Vehicles and Traffic, Article VII, Emergency No Parking, Section 505-43, Designation of Snow Emergency No Parking Areas, shall be amended and to the extent indicated repealed and replaced, with said section to read as follows:

Sec. 505-43 Designation of Snow Emergency No Parking Areas

- A. Whenever snow has fallen and the accumulation covering any designated street or highway is such that the same exceeds two (2) inches in depth, no vehicle shall be parked on the side, section or part thereof described in Schedule XXI (Sec. 505-75), attached to and made a part of this chapter.
- B. The above parking prohibitions shall remain in effect after the snow has ceased until the streets have been plowed sufficiently and to the extent that parking will not interfere with the flow of traffic.

Section 2. Chapter 505, Vehicles and Traffic, Article VII, Emergency No Parking, Section 505-44, Posting of Signs, shall be amended and retitled, and to the extent indicated repealed and replaced, with said section to read as follows:

Sec. 505-44 Additional Emergency Parking Restrictions

- A. Upon the declaration of an emergency, there shall be no parking upon streets or parts of streets where temporary emergency no-parking signs are displayed. The Chief of Police or in his absence the ranking police officer, is authorized to declare an emergency and to direct the posting of said emergency no-parking signs when weather conditions, fires or public celebrations dictate or require the avoidance of hazards or other conditions which interfere with the free flow of traffic.
- B. Notification that the emergency no-parking signs are being or will be posted shall be given to the operator or owner of any vehicle which has been parked prior to the posting of the signs.

Section 3. Chapter 505, Vehicles and Traffic, Article Vii, Emergency No Parking, Section 505-45, Removal of Vehicles, shall be amended and retitled, and to the extent indicated repealed and replaced, with said section to read as follows:

Sec. 505-45 Penalties and Removal of Vehicles

A. In addition to any other fine or penalty that may be imposed, any unoccupied vehicle parked or standing in violation of this article shall be deemed a nuisance and a menace to the safe and proper regulation of traffic, and any police or peace officer may provide for the removal of such vehicle. The owner shall pay the reasonable costs of the removal and storage which may result from such removal before regaining possession of the vehicle.

Section 4. Chapter 505, Vehicles and Traffic, Schedule XXI, Snow Emergency No Parking Areas, shall be amended and to the extent indicated repealed and replaced, with said section to read as follows:

Sec. 505-75 Schedule XXI: Snow Emergency No Parking Areas

In accordance with the provisions of Section 505-43, no person shall park a vehicle at any time upon any of the following described streets or parts of streets in violation of said section.

Section 5. Chapter 505, Vehicles and Traffic, Schedule XXI, Snow Emergency No Parking Areas, shall be amended so as to add thereto the streets or parts of streets identified on the attached schedule, made a part hereof and incorporated by reference.

Section 6. All parts and provisions of Chapter 505 not specifically affected by the above amendments and modifications shall remain in full force and effect.

Section 7. This Ordinance shall take effect twenty (20) days after final adoption and publication as provided by law.
