

**ORDINANCE NO. 2150-15**

**AN ORDINANCE TO FURTHER AMEND AND SUPPLEMENT CHAPTER 505, ARTICLE III, SCHEDULE XVIB, TIME LIMIT PARKING, STREET SWEEPING RESTRICTED PARKING, OF THE CODE OF THE BOROUGH OF HAWTHORNE SO AS TO ADD AN ADDITIONAL LOCATION THEREUNDER ON VALLEY STREET**

BE IT ORDAINED by the Municipal Council of the Borough of Hawthorne, in the County of Passaic and State of New Jersey, that:

Section 1. Chapter 505, Vehicles and Traffic, Article III, Parking, Standing and Stopping, Section 505-21, Time Limit Parking, Section 505-21 (C), Street Sweeping, and Schedule XVIB, Street Sweeping Restricted Parking, Section 505-70.1 of the Code of the Borough of Hawthorne, is hereby amended and supplemented so as to add the following additional location thereunder:

In accordance with the provisions of Sec. 505-21 (C), no person shall park a vehicle on the days and times listed in this schedule, unless otherwise indicated, upon any of the streets or parts thereof set forth in this schedule, for purposes of allowing scheduled street sweeping:

Valley Street	West	8:00 a.m. to 1:00 p.m., 2 <sup>nd</sup> and 4 <sup>th</sup> Tuesday of the month	Entire Length

Section 2. All parts and provisions of Section 505 not specifically affected by the above amendments and modifications shall remain in full force and effect.

Section 3. This Ordinance shall take effect twenty (20) days after final adoption and publication as provided by law.
