



WARD #1: Beginning at a point at the southwest corner of the Borough, which point is the intersection of the centerline of the Passaic River and the centerline extension of Prescott Avenue; thence in a northerly direction along the centerline of Prescott Avenue to a point at the intersection of the boundary line of the Borough of Hawthorne and the Borough of Prospect Park. Thence, continuing in a northerly direction along the boundary line of the Borough of Hawthorne, Prospect Park and the Borough of North Haledon to the centerline of Alana Drive extended in an easterly direction to where it intersects with the centerline of Metro Vista Drive. Thence, in a southerly direction along the centerline of Metro Vista Drive to where it intersects with the centerline of Brownstone Terrace and Hillock Avenue, thence, northeasterly and northerly along the centerline of Hillock Avenue to a point which is the intersection of Mountain Avenue and Nelson Avenue, thence from the intersection of Nelson Avenue and the centerline of Mountain Avenue to Lynack extended and thence in a southerly direction along the centerline of Lynack Road to the centerline of Goffle Road. Thence, southerly along the centerline of Goffle Road to its intersection with the centerline of Warburton Avenue. Thence easterly along the centerline of Warburton Avenue to a point which point is the centerline intersections of Warburton Avenue and Lafayette Avenue; thence, southerly along the centerline of Lafayette Avenue and Lafayette Avenue extended to a point of the intersection of that line extended and the centerline of the Passaic River which centerline serves as the boundary line between the City of Paterson and Hawthorne, and thence westerly along the centerline of the Passaic River to the point or place of beginning.

WARD #2: Beginning at a point at the intersection of the centerline of the Passaic River and Lafayette Avenue extended which point is on the boundary line between the City of Paterson and the Borough of Hawthorne thence running in a northerly direction along the centerline of Lafayette Avenue to the centerline of Rea Avenue, thence easterly along the centerline of Rea Avenue to its intersection with the centerline of Fifth Avenue southerly Fifth Avenue to centerline of Parker Avenue, thence easterly along the centerline of Parker Avenue to its intersection with the centerline of Lincoln Avenue, thence southerly along the centerline of Lincoln Avenue and along the boundary line of the Borough of Glen Rock and Fair Lawn and Lincoln Avenue extended to the centerline of the Passaic River, thence South westerly along the centerline of the Passaic River to the point or place of beginning.

WARD #3: Beginning at a point at the centerlines of intersection of Warburton Avenue and Lafayette Avenue thence in a westerly direction down the centerline of Warburton Avenue to its intersection with the centerline of Goffle Road. Thence, northerly along the centerline of Goffle Road to its intersection with the centerline of Lynack Road, thence westerly and northwesterly along the centerline of Lynack Road and Lynack Road extended to its intersection with Nelson Avenue with the centerline of Nelson Avenue and Mountain Avenue, thence, along the centerline of Hillock Avenue in a southwesterly and westerly direction to its intersection with the centerline of Metro Vista Drive, thence, northwesterly along the centerline of Metro Vista Drive to its intersection with the centerline of Alana Drive, thence along the centerline of Alana Drive to the northerly boundary line between the Borough of Hawthorne and the Borough of North Haledon and continuing to a point which is the intersection of the Borough of North Haledon, Passaic County, the Borough of Hawthorne, Passaic County, and the Township of Wyckoff, Bergen County and thence continuing North along the said boundary line between the Borough of Hawthorne and the Township of Wyckoff to a point which point is located approximately along the centerline of Goffle Hill Road thence in a southeasterly direction along the boundary line of the Borough of Hawthorne and the Township of Wyckoff to the centerline of New Jersey State Highway Route 208 and the intersection of the centerline of Lafayette Extension thence southerly along the Lafayette Extension to Goffle Road where Lafayette Avenue Extension becomes Lafayette Avenue and along that centerline of Lafayette Avenue to the centerline of Warburton Avenue which is the point and place of beginning.

WARD #4: Beginning at a point at the centerline of Lincoln Avenue which is the intersection of the centerline of Lincoln Avenue and the centerline of Parker Avenue thence westerly along the centerline of Parker Avenue to Fifth Avenue northerly along centerline of Fifth Avenue to its intersection with the centerline of Rea Avenue, thence westerly along Rea Avenue Extended to its intersection with the centerline of Lafayette Avenue and thence northerly along the centerline of Lafayette Avenue and Lafayette Avenue Extension to its centerline with the centerline of State Highway Route 208 and thence northwesterly along the centerline of State Highway Route 208 and the intersection with the boundary line between the Borough of Hawthorne and the Township of Wyckoff. Thence, southeasterly along the boundary line of Hawthorne and the Township of Ridgewood to its intersection with the centerline of Lincoln Avenue thence southerly along the centerline of Lincoln Avenue to its intersection with the centerline of Parker Avenue, being the point or place of beginning.
