

ORDINANCE NO. 2113-14

**AN ORDINANCE TO AMEND CHAPTER 45,
ENVIRONMENTAL COMMISSION, AND CHAPTER 220, FEES, OF
THE CODE OF THE BOROUGH OF HAWTHORNE SO AS TO
AUTHORIZE THE CREATION, MANAGEMENT AND
MAINTENANCE OF A COMMUNITY GARDEN BY THE
ENVIRONMENTAL COMMISSION AND SETTING FORTH FEES TO
BE CHARGED FOR UTILIZATION OF THE SAME**

BE IT ORDAINED, by the Borough Council of the Borough of Hawthorne, in the County of Passaic and State of New Jersey, as follows:

Section 1. Chapter 45, Environmental Commission, of the Code of the Borough of Hawthorne, is hereby amended and modified so as to add to the Powers and Duties of the Environmental Commission authorization to create, manage and maintain a Community Garden with such amendment to read as follows:

Ch. 45
ENVIRONMENTAL COMMISSION

Sec. 45-26. Powers and Duties

E. The Environmental Commission is authorized to create, maintain and manage a Community Garden on lands owned by the Borough of Hawthorne and specifically designated for such purpose by the Mayor of the Borough of Hawthorne. The Commission may, in furtherance of such authorization, establish rules, regulations and policies regarding use of the Community Garden and collect fees as may be authorized by Chapter 220, Fees, as established and amended from time to time.

Section 2. Chapter 220, Fees, of the Code of the Borough of Hawthorne, is hereby amended and modified so as to create Section 220-4A, Other Offices and Bodies, Article IV, Environmental Commission, to read as follows:

Ch. 220
Fees

Sec. 220-4A. Chapter 45, Other Offices and Bodies, Article IV, Environmental Commission

- A. Community Garden, annual registration fee \$25
- B. Community Garden, refundable annual deposit \$25

Section 3. If any part or parts of this Ordinance are for any reason held to be invalid, such adjudication shall not affect the validity of the remaining portions of this Ordinance.

Section 4. All Ordinances or parts of Ordinances which are inconsistent herewith are repealed, but only to the extent of such inconsistency.

Section 5. This Ordinance shall take effect twenty (20) days after final adoption and publication as provided by law.
