

ORDINANCE NO. 2117-14

AN ORDINANCE TO FURTHER AMEND AND SUPPLEMENT CHAPTER 505, ARTICLE III, SECTION 505-18, PARKING PROHIBITED AT ALL TIMES, SCHEDULE XIII, SECTION 505-19, NO STOPPING OR STANDING, SCHEDULE XIV, SECTION 505-21A, TIME LIMIT PARKING, SCHEDULE XVI, AND SECTION 505-21B, TIME LIMIT PARKING, RESIDENT RESTRICTED, ARTICLE XVI A, AS WELL AS ARTICLE IV, SECTION 505-25, OF THE CODE OF THE BOROUGH OF HAWTHORNE

BE IT ORDAINED by the Municipal Council of the Borough of Hawthorne, in the County of Passaic and State of New Jersey, that:

Section 1. Chapter 505, Vehicles and Traffic, Article III, Section 505-18, Parking Prohibited at all Times, Schedule XIII, Section 505-66, shall be amended to add thereto the following additional locations:

Sec. 505-66 Schedule XIII: Parking Prohibited at all Times

In accordance with the provisions of Section 505-18, no person shall park a vehicle at any time upon any of the following described streets or parts of streets:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
Utter Avenue	North	From the NYS&W railroad track West to the intersection of Seventh Avenue
Florence Avenue	North	From a point 123 feet west of Lafayette Avenue to a point 141 feet west of Lafayette Avenue
Lincoln Avenue	West	From the south property line of 50 Lincoln Avenue to Wagaraw Road

Section 2. Chapter 505, Vehicles and Traffic, Article III, Section 505-19, No Stopping or Standing, Schedule XIV, Section 505-67, shall be amended to add thereto the following additional locations:

Sec. 505-67 Schedule XIV: No Stopping or Standing

In accordance with the provisions of Section 505-19, no person shall stop or stand a vehicle at any time upon any of the following described streets or parts of streets:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
Lincoln Avenue	West	From Harristown Road to the south property line of 176 Lincoln Avenue

Section 3. Chapter 505, Vehicles and Traffic, Article III, Section 505-21, Time Limit Parking, Schedule XVI, Section 505-69, shall be amended to add thereto the following additional locations:

Sec. 505-69 Schedule XVI: Time Limit Parking

In accordance with the provisions of Section 505-21, no person shall park a vehicle for longer than the time limit set forth below at any time between the listed hours upon any of the following described streets or parts of streets:

<u>Name of Street</u>	<u>Side</u>	<u>Time Limit</u>	<u>Location</u>

Lincoln Avenue	West	1 hour, 8:00 a.m. to 8:00 p.m.	From the north property line of 174 Lincoln to the south property line of 116 Lincoln and from the north property line of 98 Lincoln to the south property line of 50 Lincoln

Section 4. Chapter 505, Vehicles and Traffic, Article III, Section 505-21B, Resident Restricted Time Limit Parking, Schedule XVI A, Section 505-70, shall be amended to add thereto the following additional locations:

Sec. 505-70 Schedule XVI A: Resident Restricted Time Limit Parking

In accordance with the provisions of Section 505-21B, no person shall park a vehicle for longer than the time limit set forth below at any time between the listed hours upon any of the following described streets or parts of streets unless such vehicle has displayed thereon a resident parking sticker:

<u>Name of Street</u>	<u>Side</u>	<u>Time Limit</u> <u>Hours/Days</u>	<u>Location</u>
Grand Avenue	East	* 9:00 a.m. to 10:00 a.m.	From a point 490 feet south of Diamond Bridge Avenue to and including the last head-in parking space at Llewellyn Avenue

Section 5. Chapter 505, Vehicles and Traffic, Article IV, Commuter Parking and Resident Restricted Parking Areas, Section 505-25, is amended to read as follows:

Sec. 505-25. Establishment of commuter parking and resident restricted parking areas.

There is hereby established with the Borough of Hawthorne a restricted parking area, located along the east side of Grand Avenue, from a point where head-in parking spaces located at Llewellyn Avenue end and including all parallel parking spaces from such point to the intersection with Washington Street, which shall be referred to as the nonresident commuter parking area, and shall be utilized only for nonresident commuter parking in accordance with restrictions and regulations set forth herein. There is also established a resident restricted parking area within the Borough of Hawthorne, at such locations as may be set forth in Sec. 505-70, which shall be utilized only for parking in accordance with restrictions and regulations set forth herein.

Section 6. All parts and provisions of Section 505 not specifically affected by the above amendments and modifications shall remain in full force and effect.

Section 7. This Ordinance shall take effect twenty (20) days after final adoption and publication as provided by law.
