

ORDINANCE NO. 2121-14

AN ORDINANCE TO FURTHER AMEND AND SUPPLEMENT THE CODE OF THE BOROUGH OF HAWTHORNE TO REVISE AND AMEND CHAPTER 220, FEES, SECTION 220-9, CONSTRUCTION CODE, UNIFORM, SO AS TO AMEND PERMIT FEES FOR FENCES, DRIVEWAYS AND SHEDS AND SECTION 220-12, PARKS AND RECREATION, SECTION B(1)(h) ADMISSION TO PUBLIC POOLS, DAY PASSES, RESIDENTS

BE IT ORDAINED by the Municipal Council of the Borough of Hawthorne, in the County of Passaic and State of New Jersey, that:

Section 1. Chapter 220, FEES, Section, 220-9, Construction Code, Uniform, and Section 220-12, Parks and Recreation, shall be and hereby is revised, amended and supplemented by modification of the various fees provided therein so that the same shall read as follows:

220-1 SCHEDULE OF FEES

The following schedule of fees is hereby established with respect to licenses, permits and activities required or regulated under the provisions of various chapters of the code of the Borough of Hawthorne. Applications for and the issuance of such licenses and permits shall be subject to the provisions of the specific chapter of the Code that is indicated for each type of license or permit. The business, activity or operation for which the license or permit is required shall be subject to all regulations set forth in the chapter to which reference is made.

1. Up to \$4,000 in cost	\$50
2. Over \$4,000, per \$1,000 in additional cost	\$10
U. Driveways	
1. Residential, one and two family	
a. Up to \$4,000 in cost	\$50
b. Over \$4,000, per \$1,000 in additional cost	\$10
2. Commercial, industrial and multi-family	
a. Up to \$4,000 in cost	\$100
b. Over \$4,000, per \$1,000 in additional cost	\$10
V. Sheds, residential, over 100 square feet in area	
1. Up to \$4,000 in cost	\$50
2. Over \$4,000, per \$1,000 in additional cost	\$10

For all Subcodes and sections thereof, there shall be a Department of Community Affairs surcharge fee as established by the Department from time to time.

Section 220-12. Chapter 350, Parks and Recreation.

B. Swimming Pools

1. Admission to Public Pools

(h) Day Pass (resident, all ages):	\$10
(1) Saturday, Sunday or holiday:	\$15

Section 2. All other parts or provisions of Chapter 220 of the Code of the Borough of Hawthorne or any other ordinance or regulation not specifically amended by this Ordinance shall remain in full force and effect.

Section 3. This Ordinance shall take effect twenty (20) days after final adoption and publication as provided by law.
