AN ORDINANCE TO FURTHER AMEND AND SUPPLEMENT CHAPTER 505 OF THE CODE OF THE BOROUGH OF HAWTHORNE VEHICLES AND TRAFFIC, ARTICLE II, TRAFFIC REGULATIONS, SECTION 505-5 SPEED LIMITS, SCHEDULE II, SO AS TO AMEND THE SPEED LIMIT FIXED FOR ROCK ROAD AND SECTION 505-12, STOP INTERSECTIONS, SCHEDULE VIII, SO AS TO CREATE STOP INTERSECTIONS ON HOPPER STREET AND VALLEY STREET WHERE THE SAME INTERSECT WITH BRAEN AVENUE

BE IT ORDAINED by the Municipal Council of the Borough of Hawthorne, in the County of Passaic and State of New Jersey, that:

Section 1. Chapter 505, Vehicles and Traffic, Article II, Section 505-5 Speed Limits, Schedule II, is amended so as to amend the established speed limit on Rock Road as follows:

Sec. 505-54, Schedule II: Speed Limits

In accordance with the provisions of Section 505-5, speed limits are hereby established upon the following described streets or parts thereof:

Name of Street	Speed Limit (mph)	<u>Location</u>
Rock Road	25	Entire Length

Section 2. Chapter 505, Vehicles and Traffic, Article II, Section 505-12, Stop Intersections, Schedule VIII, is amended so as to create stop intersections at the following locations:

Sec. 505-61, Schedule VIII, Stop Intersections

In accordance with the provisions of Section 505-12, the following described intersections are hereby designated as stop intersections, and stop signs shall be installed as follows:

Stop Sign on	<u>Direction of Travel</u>	At Intersection of
Hopper Street	North/South	Braen Avenue
Valley Street	North/South	Braen Avenue

Section 3. All parts and provisions of Chapter 505 not specifically affected by the above amendments and modifications shall remain in full force and effect.

Section 4. This Ordinance shall take effect after final adoption and publication as provided by law.
