

ORDINANCE NO. 2128-15

AN ORDINANCE TO AMEND CHAPTER 25 OF THE CODE OF THE BOROUGH OF HAWTHORNE, POLICE DEPARTMENT, SECTION 25-3, TABLE OF ORGANIZATION, SO AS TO ALLOW FOR INCREASE IN THE NUMBER OF INDIVIDUALS HOLDING VARIOUS RANKS IN THE EVENT OF APPROVED AND ACCEPTED TERMINAL LEAVE

BE IT ORDAINED by the Municipal Council of the Borough of Hawthorne, in the County of Passaic and State of New Jersey, that:

Section 1. Chapter 25, Police Department, Section 25-3, Table of Organization, is hereby amended so as to create thereunder section 25-3(G), permitting the maximum number of persons holding any established rank to be increased to allow for promotions in the event of terminal leave, to read as follows:

Sec. 25-3 Table of Organization.

The Table of Organization of the Police Department of the Borough of Hawthorne shall be as follows:

G. The authorized number of officers in each rank shall be increased from time to time so as to allow the Appropriate Authority, in his or her sole discretion, to permanently appoint or promote an officer to replace any Captain, Lieutenant or Sergeant no longer on active service due to approved and accepted terminal leave.

Section 2. If any section, subsection or part of this ordinance is adjudged by a Court of competent jurisdiction to be unconstitutional or invalid, such judgment shall not impair or invalidate the remainder of this ordinance.

Section 3. Except to the extent amended hereunder, all other parts or sections of Chapter 25, Police, shall remain in full force and effect. All parts and provisions of any ordinance which are inconsistent with the provisions of this ordinance shall be repealed to the extent of such inconsistency.

Section 4. This Ordinance shall take effect upon final adoption as provided by law.
