

ORDINANCE NO. 2145-15

AN ORDINANCE TO AMEND BOND ORDINANCE 2129-15, HERETOFORE ADOPTED BY THE BOROUGH OF HAWTHORNE, PROVIDING FOR ROAD RECONSTRUCTION, INCLUDING MILLING, PAVING AND RESURFACING, AS WELL AS CURBING, HANDICAPPED RAMPS AND RELATED IMPROVEMENTS ON VARIOUS STREETS AND PROPERTIES DESCRIBED HEREIN OR HEREAFTER IDENTIFIED, ALL IN AND BY THE BOROUGH OF HAWTHORNE IN THE COUNTY OF PASSAIC, NEW JERSEY, APPROPRIATING SEVEN HUNDRED FORTY THOUSAND (\$740,000) DOLLARS THEREFOR AND AUTHORIZING THE ISSUANCE OF BONDS OR NOTES OF THE BOROUGH FOR FINANCING THE SAME. SO AS TO MODIFY THE SCOPE OF WORK BY INCLUDING BRAEN AVENUE AS AN ADDITIONAL LOCATION THEREUNDER.

BE IT ORDAINED by the Municipal Council of the Borough of Hawthorne, in the County of Passaic and State of New Jersey, that:

Section 1. Bond Ordinance 2129-15, heretofore adopted on March 4, 2015, shall be and hereby is amended so as to provide at Section 3(a) thereof that the scope of work shall specifically include, in addition to all streets or locations identified in the said Ordinance, Braen Avenue, as an additional location thereunder.

Section 2. All other parts or provisions of Ordinance 2129-15, not specifically amended by this Ordinance, shall remain in full force and effect.

Section 3. This Ordinance shall take effect twenty (20) days after final adoption and publication as provided by law.
